Supply chain certification allows your company to source and sell certified products with the Rainforest Alliance Certified seal. It helps you meet the rising demand for more sustainable products and be able to access new markets while reducing potential reputational risks.

The Rainforest Alliance Certified™ seal features on food and beverages in supermarkets, trains, planes, hotels and restaurants around the world. It refers to ingredients in agricultural products which are certified against the standards of the Rainforest Alliance.

The Rainforest Alliance Sustainable Agriculture
Standard recognises farms that meet comprehensive
environmental, social and economic criteria set out
in the norm. The Rainforest Alliance Sustainable
Agriculture Supply Chain certification controls
the flow of certified farm products from farm to shelf.

2020 Rainforest Alliance Sustainable Agriculture Standard

Designed to deliver the most value to the farmers and companies that use Rainforest Alliance certification, the 2020 Certification Programme introduces numerous innovations to ensure that certification is more context-specific, data-driven and risk-based.

The updated certification programme establishes new standards for farmers and companies in the areas of human rights, livelihoods, deforestation and biodiversity and provides new data systems and tools for management.

Which agricultural products can be certified?

Raw and processed agricultural materials and ingredients: tree crops (such as coffee and cocoa), fruit (such as bananas, coconuts and pineapples), nuts (such as hazelnuts), cut flowers and vegetables. Note that special additional conditions apply to herbs, spices, rooibos and vegetables.

More than 90 agricultural crops can be certified according to the Rainforest Alliance Sustainable Agriculture Standard.
