Opportunities and challenges in wood legality: Establishing a dialogue between European importers and SMEs from Cameroon

Brussels 17 to 20 November 2014



EU importers and trade association representatives are invited to participate in a four-day study visit to strengthen information sharing between SMEs of Cameroon and importers in the EU in light of changing market requirements. The study visit will take place in Belgium with three days of meetings and site visits and a one-day workshop.

The requirements for international trade in wood and wood products are changing. Many business leaders have questions about how to meet the new requirements. The effects of the changing regulation are being felt throughout the supply chain. This study visit provides an opportunity for wood suppliers and importers to discuss better ways to meet these requirements together.
